### Costs & Travel

£995 plus VAT per company for a DIT OMIS charge (£600) & RIA Management Fee (£395)

Delegates will be responsible for their own flight bookings and related costs including hotels. A detailed programme will be provided along with a mission brochure.

## Australia

Australia has fared better than most countries from the impact of the COVID-19 pandemic, with GDP figures holding stronger than many Western economies. Infrastructure spending as a stimulus package remains high, with major works continuing to be funded particularly in Western Sydney and Greater Melbourne, with plenty on the horizon with the announcements for the 2026 Commonwealth Games to be hosted in regional Victoria and the 2032 Olympics to be in Brisbane.

The rail focus is twofold: heavy rail for freight, primarily overland, and rail for metro systems. New metro systems are underway in Sydney and Melbourne, including links to Melbourne's existing International Airport and Sydney's new second International Airport. Underpinning this growth is a strong demand for rolling stock and maintenance. All State Governments are regularly releasing contracts to supply new rolling stock for current projects, as well as, refreshing existing fleets. Additionally, there is a focus on upgrading regional railway systems, both passenger and freight, particularly in NSW and Victoria.

## New Zealand

Auckland's City Rail Link (CRL), the country's first underground rail loop currently under construction, is set to be followed by the Auckland Light Rail project's CBD-Auckland Airport line. The Government is also investigating additional heavy rail capacity in the Upper North Island, including a spur line from the main freight rail corridor north of Auckland to the port of Whangarei and a rapid regional rail network to link Auckland to the fast-growing city of Hamilton.

## UK-Australia and UK-New Zealand Free Trade Agreements

The UK signed a free trade agreement with Australia in December 2021 and New Zealand in February 2022. The new trade deals will lower tariffs, improve mobility and simplify trade and investment regulations, making it easier to do business in Australia and New Zealand.
